SUBJECT: Fringe Benefit Rates for Contract and Grant Proposals
 Effective July 1, 2009

The following are the current fringe benefit rates for contracts and grants. The fringe benefit rates are for all salary/OPS personnel on established contracts and grants payroll lines. Exclude consultants and independent contractors in the business of offering services on a contract basis for a limited period of time.

These rates are ESTIMATES for contracts and grants budget proposal preparations only. ACTUAL fringe costs are charged to each contract or grant based on the individual employee's actual fringe benefits costs.

Fringe Benefits

Please note the following:

Rates for the Payroll Matching items; Retirement, State Health/HMO and State Life Insurance, are calculated by taking total fringe costs and dividing them by total payroll costs for externally sponsored awards. Specific benefit rates can be found on the Human Resources Web Page at <http://www.hr.ucf.edu/> or by contacting Human Resources.

The FICA Alternative Plan reduces Payroll Matching for FICA to 1.45% for the OPS and PDA categories. Information on the FICA Alternative Plan can be found on the Human Resources Web Page also.

Miscellaneous Fringe items are not applied during the Payroll process but are charged once a month during the month end general ledger closing process and are applied to all externally sponsored awards.
